

## TERMS AND CONDITIONS

### UOBM LADY'S CARD: BODY PERFECT PROMOTION

#### Promotion Eligibility

1. United Overseas Bank (Malaysia) Bhd. (271809-K) ("UOBM") **UOBM Lady's Card Body Perfect Promotion** ("the Promotion") is open to all eligible UOBM **principal and supplementary UOBM Lady's Card Cardmembers** ("Cardmembers") whose account(s) are current, valid, subsisting and in good credit standing as may be determined by UOBM at its sole and absolute discretion.
2. This Promotion is only applicable to **UOBM Lady's Card** issued in Malaysia.
3. The following shall **not** be eligible for the Promotion:-
  - i. Cardmembers whose account(s) are terminated, suspended or cancelled within the Promotion Period (as defined in Clause 4 below);
