

ENJOY UP TO ADDITIONAL 7% OFF AT REEBONZ

TERMS & CONDITIONS

UOBM CREDIT AND/OR DEBIT CARD ("CARD")

Eligibility

1. United Overseas Bank (Malaysia) Bhd (271809-K) ("UOBM") Enjoy up to additional 7% off at Reebonz ("Promotion") is open to all eligible principal and supplementary UOBM Credit and/or Debit Card members ("Cardmembers") whose account(s) are current, valid, subsisting and in good credit standing as may be determined by UOBM at its sole and absolute discretion.
2. This Promotion is only applicable to UOBM Credit and/or Debit Cards issued in Malaysia.
3. The following shall not be eligible for the Promotion:-
 - a. All UOBM Corporate, Purchasing and Private Label Cardmembers;
